Try-Us-Out Customer Agreement and Privacy Statement

This document establishes an agreement between the customer and PhotoFresh USA.

1. **Services.** The Try Us Out service allows for scans of up to 5 slides, 35mm negatives or prints, in any combination, to be scanned for one price. Prints may not exceed 8x10 inches in size.
2. **Refund of Fee.** The cost of this service will be credited to the customer's account if an order exceeding \$100 is placed with PhotoFresh USA within 60 days of the Try Us Out service.
3. **Image ownership.** The customer retains all ownership and copyright on all images.
4. **Copying Scans.** The customer may make one or more copies of the final scans.
5. **Disposition of scans and originals.** PhotoFresh USA will supply the requested scans via email, and originals will be returned to the customer via US Mail, upon completion of the project.
6. **Copies of all images will be stored on secured computers and/or servers** during the scanning process, and for a period of sixty (60) days after the delivery of the final product. All requests for replacement scans must be received by PhotoFresh USA within the sixty-day retention period. At the conclusion of the retention period, all images shall be deleted by PhotoFresh USA from all electronic equipment on which they may be stored.
7. **Preservation of originals.** PhotoFresh USA shall make every effort to protect and preserve all original items. PhotoFresh USA is not responsible for loss or damage to originals due to acts of God.
8. **Image Enhancement.** PhotoFresh USA will make every effort to scan each image, and may make, at their discretion, slight color, contrast and/or brightness adjustments in order to improve final image quality. However, physical damage to the originals (including but not limited to scratches, tears, chemical discoloration, extreme over- and underexposure, double exposures and mold deposits) may preclude creating a successful final product. PhotoFresh USA may opt to provide the scan without correction for those pictures which are beyond repair, with no reduction in the price of this service.
9. **Copyright protection.** In order to preserve the copyrights of original photograph owners, commercially available pictures will not be scanned.
10. **Pornography.** At the sole discretion of PhotoFresh USA, images depicting pornography will not be scanned. Originals will be returned to the customer, with no reduction in the price of this service.
11. **Your privacy is important to us.** PhotoFresh USA shall not share or post any of the Customer's images in any form on any Internet site, Usenet group, File Server or equivalent public site. No one unaffiliated with PhotoFresh USA will have access to view or copy any images at any time. PhotoFresh USA does not share or release the customer's name, address, phone number(s) nor any personal information to any third party, and has no plans to do so in the future.
